RESOLUTION GRANTING AUTHORITY TO THE PROVINCIAL GOVERNOR, HON. EUGENIO JOSE V. LACSON, TO SIGN FOR AND ON BEHALF OF THE PROVINCE, THE DEED OF SALE TO BE ENTERED INTO BY AND BETWEEN THE SIETES MARIA, INC. AND THE PROVINCE OF NEGROS OCCIDENTAL RELATIVE TO THE SALE OF A TEN THOUSAND (10,000) SQ. METER PROPERTY IDENTIFIED AS LOT NO. 732-D-2 COVERED BY TCT NO. T-3417, LOCATED AT BRGY. GUIMBALA-ON, SILAY CITY, NEGROS OCCIDENTAL TO BE UTILIZED FOR THE NEGROS OCCIDENTAL BULK WATER SUPPLY PROJECT IN THE AMOUNT OF THIRTEEN MILLION PESOS (P13,000,000.00)
