RESOLUTION NO. 0345 Series of 2025

RESOLUTION ADOPTING THE GUIDELINES ON THE IMPOSITION OF LOCAL BUSINESS TAX, FEES AND CHARGES TO SERVICE CONTRACTORS

WHEREAS, the Provincial Government of Negros Occidental acknowledges the need to ensure that service contractors operating within the province comply with the local tax and fee regulations as set forth by the Department of Finance;

WHEREAS, the Department of Finance has issued Local Finance Circular No. 001-2022, which provides the guidelines on the imposition of local business tax, fees, and charges to service contractors;

WHEREAS, the Provincial Government of Negros Occidental affirms the need to implement these guidelines to promote compliance, support the local economy, and ensure that revenue is generated for the province's programs and services;

WHEREAS, the Provincial Government of Negros Occidental, in recognizing the importance of ensuring uniformity, transparency, and clarity in tax imposition, deems it appropriate to adopt these guidelines to be implemented within its jurisdiction;

NOW THEREFORE, on motion of Hon. Rommel T. Debulgado, unanimously seconded by all the members present,

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves to adopt the guidelines outlined in Department of Finance Local Finance Circular No. 001-2022 for the imposition of local business tax, fees, and charges to service contractors.
