RESOLUTION ADOPTING THE OMNIBUS GUIDELINES ON THE SUSPENSION OF LGU IMPOSITION AND COLLECTION OF ILLEGAL FEES AND TAXES RELATIVE TO THE TRANSPORT OF GOODS AND PRODUCTS

WHEREAS, the Provincial Government of Negros Occidental fully supports the nationwide effort to ensure the transport of goods and products is not unduly hindered by illegal fees and taxes imposed by local government units (LGUs) or other agencies;

WHEREAS, the Department of the Interior and Local Government (DILG), in coordination with other relevant agencies, issued Joint Memorandum Circular No. 2021-01, which provides omnibus guidelines on the suspension of LGU imposition and collection of illegal fees and taxes in relation to the transport of goods and products;

WHEREAS, the suspension aims to protect the local business sector and facilitate the smooth and efficient transport of goods while ensuring compliance with proper taxation protocols;

WHEREAS, the Provincial Government of Negros Occidental recognizes the importance of adhering to the legal guidelines set forth in Joint Memorandum Circular No. 2021-01 and desires to adopt these guidelines within the jurisdiction of the province;
