RESOLUTION AUTHORIZING THE GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE CONSULTANCY AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND DR. IRIS LEE B. TOMAMPOS RELATIVE TO THE ENGAGEMENT OF HER SERVICES AS INTERNAL MEDICINE CONSULTANT AT THE DON SALVADOR BENEDICTO MEMORIAL DISTRICT HOSPITAL FOR THE PERIOD JANUARY 1, 2025 TO DECEMBER 31, 2025

WHEREAS, thereby presented to the Board for review and appropriate action is the request of the Governor for authority to sign, for and in behalf of the Province, the Consultancy Agreement to be entered into by and between the Province of Negros Occidental and Dr. Iris Lee B. Tomampos relative to the engagement of her services as Internal Medicine Consultant at the Don Salvador Benedicto Memorial District Hospital for the period January 1, 2025 to December 31, 2025;

WHEREAS, under said agreement, the province shall pay Dr. Tomampos the sum of Thirty Thousand Pesos (P30,000.00) per month in consideration of the services rendered as Internal Medicine Consultant by conducting at least two (2) regular visits in a week at said hospital;

WHEREAS, in view of the foregoing, the SP Committee on Health recommends approval of the same;
