RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2024-007 OF THE CITY OF KABANKALAN, NEGROS OCCIDENTAL, COVERING THE 2024 GENERAL FUND SUPPLEMENTAL BUDGET NO. 6 OF THE SAID CITY IN THE AMOUNT OF TEN MILLION PESOS (P10,000,000.00)

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the 2024 General Fund Supplemental Budget No. 6 of the City of Kabankalan, Negros Occidental with a total appropriation of P10,000,000.00, enacted by the Sanggunian Panlungsod per Appropriation Ordinance No. 2024-007;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A. No. 7160, otherwise known as the Local Government Code of 1991, and Joint Circular No. 93-2 of the Commission on Audit and the Department of Budget and Management dated June 8, 1993 and other implementing circulars and issuances, as pre-reviewed and endorsed by the Provincial Budget Officer and the Local Finance Committee;

WHEREAS, in view of the foregoing, the SP Committee on Budget and Finance recommends approval of the same;

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Appropriation Ordinance No. 2024-007 of the City of Kabankalan covering the 2024 General Fund Supplemental Budget No. 6 of the said city with a total appropriation of P10,000,000.00 and considered operative in its entirety effective December 26, 2024 subject to the posting requirement under Section 59 of LGC 1991 and the following conditions and reminders:

1. the grant of Gratuity Pay to COS and JO workers shall be in accordance with the provisions of Budget Circular No. 2024-8, dated December 20, 2024 of the DBM; and
2. strict adherence in the period as to the submission of Appropriation Ordinances to the Sangguniang Panlalawigan for review per Section 56(a) of RA 7160 which states that: "Review of Component Cities and Municipal Ordinances or Resolutions by the Sangguniang Panlalawigan - (a) within three (3) days after approval, the Secretary to the Sangguniang Panlungsod or Sangguniang Bayan shall forward to the Sangguniang Panlalawigan for review, copies of approved ordinances and resolutions approving local development plans and public investment programs formulated by the local development councils".

RESOLVED FURTHER, that the accuracy of the statement/certification and other supporting documents contained in this supplemental budget as well as the observance with other existing laws, rules and regulations shall be the responsibility of the city government.

ADOPTED UNANIMOUSLY.

This resolution shall take effect immediately upon approval.
