RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2025-01 OF THE CITY OF LA CARLOTA, NEGROS OCCIDENTAL APPROVING THE 2025 GENERAL FUND SUPPLEMENTAL BUDGET NO. 1 OF THE SAID CITY IN THE TOTAL AMOUNT OF ONE HUNDRED SIXTY THOUSAND SEVENTY SEVEN PESOS (P160,077.00)
