RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2025-01 OF THE CITY OF BAGO, NEGROS OCCIDENTAL COVERING THE FY 2025 GENERAL FUND SUPPLEMENTAL BUDGET NO. 1 OF THE SAID CITY IN THE AMOUNT OF TWENTY THREE MILLION ONE HUNDRED TWENTY THOUSAND PESOS (\$\mathbb{P}\$23,120,000.00)

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the FY 2025 General Fund Supplemental Budget No. 1 of the City of Bago, Negros Occidental, with a total appropriation of Twenty Three Million One Hundred Twenty Thousand Pesos (₱23,120,000.00), enacted by the Sangguniang Panlungsod per Appropriation Ordinance No. 2025-01;

WHEREAS, the above-mentioned budget shows apparent compliance with the same law, its Implementing Rules and Regulations, CY 2016 Budget Operations Manual for Local Government Units, and implementing circulars and other issuances;

WHEREAS, in view of the foregoing, the SP Committee on Finance recommends approval of the same;

NOW THEREFORE, on motion of Hon. Rommel T. Debulgado, unanimously seconded by all the members present,

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve and declare operative as of the date of its stated effectivity, the Appropriation Ordinance No. 2025-01 of the City of Bago, Negros Occidental, subject to the following conditions:

- The utilization of the 20% Development Fund shall be utilized and disbursed in accordance with the provisions of Joint Memorandum Circular (JMC) No. 1 of the DBM, DoF and DILG dated November 4, 2020. Moreover, purchase, maintenance or repair of motor vehicles used for administrative purposes shall not be allowed under the same JMC.
- The purchase and specification of the motor vehicles shall be subject to the provisions of Administrative Order No. 14 dated December 10, 2018; Budget Circular No. 2022-1 dated February 11, 2022 and Budget Circular No. 2022-1A dated March 1, 2023 of the DBM.
- The grant of Gratuity Pay for Contract of Service (COS) and Job Order (JO) Workers in Government for FY 2024 shall be in accordance with the provisions of Budget Circular No. 2024-8 dated December 20, 2024 of the Department of Budget and Management.
- 4. That Section 54 of the Local Government Code provides that every ordinance enacted by the sangguniang panlungsod shall be presented to the city mayor, as the case maybe. If the LCE concerned approves the same, he shall affix his signature on each and every page thereof.
- 5. That Section 56 in relation with Section 326 and 327 of the LGC which provides that within three (3) days after approval of the Ordinance authorizing annual or supplemental appropriations, the Secretary to the Sanggunian shall forward the said Ordinance to the appropriate reviewing authority.

RESOLVED FURTHER, that the accuracy of the statements/certifications and other supporting documents contained in this supplemental budget as well as observance with other existing laws, rules and regulations shall be the responsibility of the city government;

RESOLVED FURTHERMORE, that compliance with the existing laws, rules and regulations shall be the responsibility of the city.

ADOPTED UNANIMOUSLY.

This resolution shall take effect immediately upon approval.
