RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2024-07 OF THE MUNICIPALITY OF LA CASTELLANA, NEGROS OCCIDENTAL COVERING THE FY 2024 GENERAL FUND SUPPLEMENTAL BUDGET NO. 6 OF THE SAID MUNICIPALITY IN THE AMOUNT OF THREE MILLION SEVEN HUNDRED SEVEN THOUSAND TWO HUNDRED EIGHTY FIVE PESOS AND SIXTY CENTAVOS (P3,707,285.60)

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the FY 2024 General Fund Supplemental Budget No. 6 of the Municipality of La Castellana, Negros Occidental, with a total appropriation of Three Million Seven Hundred Seven Thousand Two Hundred Eighty Five Pesos and Sixty Centavos (P3,707,285.60), enacted by the Sangguniang Bayan per Appropriation Ordinance No. 2024-07;

WHEREAS, the above-mentioned budget shows apparent compliance with the same law, its Implementing Rules and Regulations, Budget Operations Manual, 2023 Edition for Local Government Units, and implementing circulars and other issuances;

WHEREAS, in view of the foregoing, the SP Committee on Finance recommends approval of the same;

NOW THEREFORE, on motion of Hon. Rommel T. Debulgado, unanimously seconded by all the members present,

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve and declare operative in its entirety effective December 27, 2024, the Appropriation Ordinance No. 2024-07 of the Municipality of La Castellana, Negros Occidental, subject to the posting requirements under Section 59 of LGC 1991, and the following conditions:

1. The grant of Service Recognition Incentive (SRI) shall be in accordance with the provisions of Budget Circular No. 2024-7, dated December 16, 2024 of the Department of Budget and Management;
2. The disbursement of donations shall be used solely for public purposes and subject to Section 36 and 305(b) of the LGC of 1991; and
3. The adherence in the period as to the submission of Appropriation Ordinance to the Sangguniang Panlalawigan for review per Section 56(a) of R.A. 7160, which states that: "Review of the component city or municipal ordinances or Resolutions by the Sangguniang Panlalawigan – (a) Within three (3) days after approval, the secretary to the Sangguniang Panlungsod or Sangguniang Bayan shall forward to the Sangguniang Panlalawigan for review, copies of approved ordinances and the resolutions approving the local development plans and public investment programs formulated by the local development councils".

RESOLVED FURTHER, that the accuracy of the statements/certifications and other supporting documents contained in this supplemental budget as well as observance with other existing laws, rules and regulations shall be the responsibility of the municipal government.

ADOPTED UNANIMOUSLY.

This resolution shall take effect immediately upon approval.
