RESOLUTION DECLARING MUNICIPAL ORDINANCE NO. 2025-01 OF THE MUNICIPALITY OF BINALBAGAN, NEGROS OCCIDENTAL, EXTENDING THE PERIOD OF PAYMENT OF BUSINESS TAXES AND CHARGES AND RENEWAL OF BUSINESS PERMITS AND LICENSES FROM JANUARY 21, 2025 TO JANUARY 31, 2025 WITHOUT SURCHARGES AND PENALTIES AS A VALID ENACTED ORDINANCE

WHEREAS, Section 56 of the Local Government Code of 1991 expresses the reviewing power of the Sangguniang Bayan on Component City and Municipal Ordinances and Resolutions declaring the Ordinance or Resolution valid if it is consistent with the law or invalid in whole or in part if the Sangguniang Panlalawigan finds the Ordinance or Resolution to be beyond the power conferred upon the Sangguniang Panlangsod or Sangguniang Bayan concerned;

WHEREAS, Municipal Ordinance No. 2025-01 of the Municipality of Binalbagan, Negros Occidental, entitled: "AN ORDINANCE EXTENDING THE PERIOD OF PAYMENT OF BUSINESS TAXES AND CHARGES AND RENEWAL OF BUSINESS PERMITS AND LICENSES FROM JANUARY 21, 2025 TO JANUARY 31, 2025 WITHOUT SURCHARGES AND PENALTIES" was submitted for review by the Municipality of Binalbagan to the Sangguniang Panlalawigan of Negros Occidental;

WHEREAS, after prompt examination by the Provincial Legal Office, it is the recommendation of the said Office that the subject Ordinance is within the conferred power of the Sangguniang Bayan of Binalbagan enact, thus, the same may be given due course by the Sangguniang Panlalawigan;
