RESOLUTION NO. 0367 Series of 2025

RESOLUTION APPROVING MUNICIPAL ORDINANCE NO. 2025-02 OF THE MUNICIPALITY OF BINALBAGAN, NEGROS OCCIDENTAL EXTENDING THE DEADLINE IN THE PAYMENT OF BUSINESS TAXES AND CHARGES AND RENEWAL OF BUSINESS PERMITS AND LICENSES WITHOUT CHARGES AND PENALTIES FROM FEBRUARY 1, 2025 TO FEBRUARY 10, 2025

WHEREAS, thereby presented for review and appropriate action of the Board is Municipal Ordinance No. 2025-02 of the Municipality of Binalbagan extending the deadline in the payment of business taxes and charges and renewal of business permits and licenses without charges and penalties from February 1, 2025 to February 10, 2025;

WHEREAS, the power of a Sangguniang Bayan to extend tax payment deadlines without penalties is explicitly granted under RA 7160 or the Local Government Code, to wit:

Section 167 – "Unless otherwise provided in this Code, all local taxes, fees and charges shall be paid within the first twenty (20) days of January or of each subsequent quarter, as the case may be. The Sangguniang concerned may, for a justifiable reason or cause, extend the time for payment of such taxes, fees, or charges without surcharges or penalties, but only for a period not exceeding six (6) months;"

WHEREAS, in view of the foregoing, the SP Committee on Finance, recommends approval of the same;
