**RESOLUTION APPROVING ORDINANCE NO. 25-01 OF THE CITY OF SAN CARLOS AMENDING ORDINANCE NO. 24-22, ENTITLED: AN ORDINANCE IMPLEMENTING THE PARTIAL REORGANIZATION OF THE ORGANIZATIONAL STRUCTURE AND STAFFING PATTERN OF THE CITY GOVERNMENT OF SAN CARLOS, NEGROS OCCIDENTAL, PURSUANT TO SECTION 76 OF RA 7160 AND RA 6758, BY ADDING PROVISIONS THEREOF AND FOR OTHER PURPOSES**

**WHEREAS**, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Ordinance No. 25-01 of the City of San Carlos amending Ordinance No. 24-22, entitled: An ordinance implementing the partial reorganization of the organizational structure and staffing pattern of the City Government of San Carlos, Negros Occidental, pursuant to Section 76 of RA 7160 and RA 6758, by adding provisions thereof and for other purposes;

**WHEREAS**, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

**WHEREAS**, a review of the subject ordinance reveals that the same is within the power of the Sangguniang Panlungsod of the City of San Carlos to enact and in accordance with the Section 76 of R.A. 7160, otherwise known as the Local Government Code of 1991, as well as R.A. 6758 which establishes the Compensation and Position Classification System for Government Employees;

**WHEREAS**, in view of the foregoing, the SP Committee on Human Resource recommends approval of the same;

**NOW, THEREFORE**, on motion of Hon. Rommel T. Debulgado, unanimously seconded by all the members present,
