**RESOLUTION REITERATING RESOLUTION NO. 0481, SERIES OF 2023,  
OTHERWISE KNOWN AS “RESOLUTION APPEALING TO HONORABLE  
EUGENIO JOSE “BONG” LACSON, GOVERNOR, PROVINCE OF NEGROS

**WHEREAS**, booths of different Local Government Units have remained serving the public as well as showcasing its product and services in an iconic booth which are the resemblance of their respective government centers, however, the Province of Negros Occidental perhaps forgotten to include the construction of a replicated Provincial Capitol Building serving as iconic symbol of the provincial government;

**WHEREAS**, the imperative of a replicated or miniaturized Provincial Capitol Building either at the entrance of the Panaad Park and Stadium or at the center stage where activities are usually held will serve its purpose of preserving and maintaining its primary role as the motherhouse of unifying all Local Government Units in one location which is the Panaad Park and Stadium;

**WHEREAS**, in view of the foregoing, the SP Committee on Laws recommends approval of the same;

**NOW THEREFORE**, on motion of Hon. Sixto Teofilo Roxas V. Guanzon, Jr., unanimously seconded by all the members present;


