RESOLUTION GRANTING AUTHORITY TO THE PROVINCIAL TREASURER TO CHARGE AGAINST THE CURRENT BUDGET UNDER THE 2025 SPECIAL PURPOSE APPROPRIATIONS – TERMINAL LEAVE BENEFITS ACCOUNT THE UNPAID TERMINAL LEAVE PAY OF FORMER BOARD MEMBER JUVY A. PEPELLO IN THE TOTAL AMOUNT OF ONE MILLION SIXTEEN THOUSAND EIGHT HUNDRED SIXTY THREE PESOS AND EIGHTY THREE CENTAVOS (P1,016,863.83)

WHEREAS, thereby presented to the Board for review and appropriate action is the request of the Governor to grant authority to the Provincial Treasurer to charge against the current budget under the 2025 Special Purpose Appropriations – Terminal Leave Benefits account the unpaid terminal leave pay of Former Board Member Juvy A. 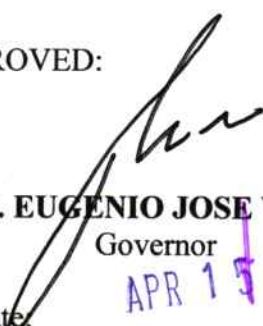
