***RESOLUTION APPROVING RESOLUTION NO. 2024-1473 OF THE CITY OF VICTORIAS, NEGROS OCCIDENTAL ADOPTING THE CITY NUTRITION PLAN (CNAP) 2024-2026***

**WHEREAS**, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Resolution No. 2024-1473 of the City of Victorias, Negros Occidental entitled: “Adopting the City Nutrition Plan (CNAP) 2024-2026”, which was submitted by the City of Victorias to the Sangguniang Panlalawigan;

**WHEREAS**, the City of Victorias finds legal support from Republic Act No. 11037, otherwise known as the “Masustansyang Pagkain Para sa Batang Pilipino Act”; Republic Act No. 11148, or the “Kalusugan at Nutrisyon ng Mag-Nanay Act”, and Section 17(b) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, Republic Act No. 11037, or the “Masustansyang Pagkain Para sa Batang Pilipino Act” establishes a national feeding program to combat child hunger and malnutrition by providing fortified meals, milk and nutrition education in public daycare centers, kindergarten, and elementary schools. Section 4 mandates the creation of the National Feeding Program, while Section 6 directs the National Nutrition Council (NNC) to integrate national and local nutrition data to identify and monitor malnourished children. This Ordinance aligns with these objectives by strengthening nutrition programs in the City of Victorias;

**WHEREAS**, Republic Act No. 11148, or the “Kalusugan at Nutrisyon ng Mag-Nanay Act”, enhances health and nutrition programs, focusing on the first 1,000 days of life. Section 2 affirms the State’s commitment to ensuring adequate food, care, and nutrition for pregnant and

lactating women, adolescent girls, and young children, while Section 5 prioritizes nutritionally at-risk individuals, including teenage mothers, and children up to 24 months of old. This ordinance supports these goals by institutionalizing maternal and child health initiatives in the city;

**WHEREAS**, Section 17(b) (4) of Republic Act No. 7160 states that the local government units are responsible for providing social welfare services, including programs and projects focused on child and youth welfare, family, and community welfare, women's welfare, livelihood initiatives, and nutrition services. The proposed ordinance is in line with this mandate, allowing the City of Victorias to develop and implement programs that support the health and well-being of its constituents;

**WHEREAS**, in view of the foregoing, the SP Committee on Finance recommends approval of the same,

**NOW THEREFORE**, on motion of Hon. Rommel T. Debulgado, unanimously seconded by all members present,

**THE SANGGUNIANG PANLALAWIGAN RESOLVED**, as it hereby resolves to approve Resolution No. 2024-1473 of the City of Victorias, Negros Occidental adopting the City Nutrition Plan (CNAP) 2024-2026.

This resolution shall take effect immediately upon approval.
