**RESOLUTION APPROVING CITY ORDINANCE NO. 2, SERIES OF 2025 OF THE CITY OF SILAY AUTHORIZING THE CITY TREASURER OF THE CITY OF SILAY, TO COLLECT FROM THE LOCALIZED COMMUNITY MORTGAGE PROGRAM (LCMP) BENEFICIARIES, THE CITY'S COUNTERPART ASSISTANCE COST EQUIVALENT TO AT LEAST 25% OF THE PROJECT COST AND CREATING A SPECIAL TRUST FUND ACCOUNT FOR THE SAID PURPOSE**

**WHEREAS**, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is City Ordinance No. 2, series of 2025 of the City of Silay authorizing the City Treasurer of the City of Silay, to collect from the Localized Community Mortgage Program (LCMP) beneficiaries, the city's counterpart assistance cost equivalent to at least 25% of the project cost and creating a special trust fund account for the said purpose;

**WHEREAS**, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

**WHEREAS**, a review of the subject ordinance reveals that the same is within the power of the Sangguniang Panlungsod of the City of Silay to enact and in accordance with the Section 16 (General Welfare Clause), Section 18 and Section 22(c) of R.A. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, in view of the foregoing, the SP Committee on Finance recommends approval of the same;

**NOW, THEREFORE**, on motion of Hon. Rommel T. Debulgado, unanimously seconded by all the members present,
