RESOLUTION APPROVING ORDINANCE NO. 2025-169 OF THE CITY OF VICTORIAS WAIVING THE RENTAL FEES OF CANOPY TENTS AND MONOBLOCK CHAIRS FOR THE EXCLUSIVE USE OF VICTORIASANONS IN WAKES AND FUNERALS AND PRESCRIBING THE GUIDELINES FOR THE IMPLEMENTATION THEREOF

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Ordinance No. 2025-169 of the City of Victorias waiving the rental fees of canopy tents and monoblock chairs for the exclusive use of Victoriasanons in wakes and funerals and prescribing the guidelines for the implementation thereof;

WHEREAS, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

WHEREAS, a review of the subject ordinance reveals that the same is within the power of the Sangguniang Panlungsod of the City of Victorias to enact and in accordance with the Section 16 (General Welfare Clause), Section 17 of R.A. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, in view of the foregoing, the SP Committee on Finance recommends approval of the same;
