RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 01, SERIES OF 2025 OF THE MUNICIPALITY OF TOBOSO, NEGROS OCCIDENTAL ENTITLED: "AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 1, SERIES OF 2025 OF THE MUNICIPALITY OF TOBOSO, NEGROS OCCIDENTAL INVOLVING AN AMOUNT OF THREE MILLION THREE HUNDRED TWENTY-ONE THOUSAND THIRTY-EIGHT PESOS (P3,321,038.00)"

WHEREAS, thereby presented for appropriate action of the Sangguniang Panlalawigan of the Province of Negros Occidental is Appropriation Ordinance No. 01, Series of 2025 of the Municipality of Toboso, Negros Occidental entitled: "AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 1, SERIES OF 2025 OF THE MUNICIPALITY OF TOBOSO, NEGROS OCCIDENTAL INVOLVING AN AMOUNT OF THREE MILLION THREE HUNDRED TWENTY-ONE THOUSAND THIRTY-EIGHT PESOS (P3,321,038.00)";

WHEREAS, the pre-review shows substantial compliance with the same law, the Implementing Rules and Regulations, Budget Operations Manual for Local Government Units, 2023 Edition and with implementing circulars and other issuances;

WHEREAS, the same is recommended for approval and declared operative in its entirety effective January 21, 2025 subject to the posting requirements under Section 59 of LGC and shall further be subject to the following conditions and reminders:

1. *The reprogramming of the 2-24 Local Disaster Risk Reduction and Management Fund (LDRRMF) shall be in accordance with Section 3 of Rule 18 of the IRR of RA No. 10121 which provides Unexpended LDRRMF shall accrue to a special trust fund solely for the purpose of supporting disaster risk reduction and management activities of the LDRRMCs within the next five (5) years. Any such amount still not*

fully utilized after five (5) years shall revert back to the general fund and made available for other social services to be identified by the local sanggunian". Moreover, Section 5.1.11 of CDA Circular No. 2012-002 dated September 12, 2012 provides "All unexpended/unobligated balance of the LDRRMF for CO shall be made continuing in the General Fund books until the projects funded therefore are completed and any savings shall be available for use in the disaster risk reduction and management activities as provided in the LDRRMFIP";

- 1. The utilization of the 20% Development Fund shall be utilized and disbursed in accordance with the provisions of Joint Memorandum Circular (JMC) No. 1 of the DBM, DoF and DILG dated November 4, 2020;*
- 2. The purchase and specification of the motor vehicles shall be subject to the provisions of Administrative Order No. 14 dated December 10, 2018, Budget Circular No. 2022-1 dated February 11, 2022 and Budget Circular No. 2023-1A dated March 11, 2023 of the DBM;*

WHEREAS, in view of the foregoing, the SP Committee on Finance recommends approval of the same;

NOW THEREFORE, on motion of Hon. Rommel T. Debulgado, unanimously seconded by all the members present;

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Appropriation Ordinance No. 1, Series of 2025 of the Municipality of Toboso, Negros Occidental entitled: "AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 1, SERIES OF 2025 OF THE MUNICIPALITY OF TOBOSO, NEGROS OCCIDENTAL INVOLVING AN AMOUNT OF THREE MILLION THREE HUNDRED TWENTY-ONE THOUSAND THIRTY-EIGHT PESOS (P3,321,038.00)";

RESOLVED FURTHER, it is understood that this review action does not authorizes any item of appropriation that is specifically prohibited by or inconsistent with the provisions of the law;

RESOLVED FURTHERMORE, the accuracy of the statements/certifications and other supporting documents contained in this supplemental budget as well as observance with other existing laws, rules and other regulations shall be the responsibility of the city government;

RESOLVED FINALLY, compliance with the existing laws, rules and regulations shall be the responsibility of the city government.

This resolution shall take effect immediately upon approval.
