**RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 25-02 OF THE
CITY OF BAGO, NEGROS OCCIDENTAL ENTITLED: "AN ORDINANCE
AUTHORIZING THE SUPPLEMENTAL BUDGET NO. 2, SERIES OF 2025
INVOLVING AN AMOUNT OF TWO MILLION SEVEN HUNDRED THOUSAND
PESOS (P2,700,000.00)"**

WHEREAS, thereby presented for appropriate action of the Sangguniang Panlalawigan of the Province of Negros Occidental is Appropriation Ordinance No. 25-02 of the City of Bago, Negros Occidental entitled: "AN ORDINANCE AUTHORIZING THE SUPPLEMENTAL BUDGET NO. 2, SERIES OF 2025 INVOLVING AN AMOUNT OF TWO MILLION SEVEN HUNDRED THOUSAND PESOS (P2,700,000.00)";

WHEREAS, the pre-review shows substantial compliance with the same law, the Implementing Rules and Regulations, Budget Operations Manual for Local Government Units, 2023 Edition and with implementing circulars and other issuances;

WHEREAS, the same is recommended for approval and declared operative in its entirety effective February 21, 2025 subject to the posting requirements under Section 59 of LGC and shall further be subject to the following conditions and reminders:

- 1. The utilization of the 20% Development Fund shall be utilized and disbursed in accordance with the provisions of Joint Memorandum Circular (JMC) No. 1 of the DBM, DOF, and DILG dated November 4, 2020. Moreover, purchase, maintenance or repair of motor vehicles used for administrative purposes shall not be allowed under the same JMC;*
- 2. The purchase and specification of the motor vehicles shall be subject to the provisions of Administrative Order No. 14 dated December 10, 2018; Budget Circular No. 2022-1 dated February 11, 2022 and Budget Circular No. 2022-1A dated March 1, 2023 of the DBM;*

3. *That Section 54 of the Local Government Code provides that every ordinances enacted by the sangguniang bayan shall be presented to the city mayor, as the case may be. If the LCE concerned approves the same, he shall affix his signature on each and every page thereof;*
4. *That Section 56 in relation with Section 326 and 327 of the LGC which provides that within three (3) days after approval of the Ordinance authorizing annual or supplemental appropriations, the Secretary to the Sangguniang shall forward the said Ordinance to the appropriate reviewing authority;*

WHEREAS, in view of the foregoing, the SP Committee on Finance recommends approval of the same;

NOW THEREFORE, on motion of Hon. Rommel T. Debulgado, unanimously seconded by all the members present;

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Appropriation Ordinance No. 25-02 of the City of Bago, Negros Occidental entitled: "AN ORDINANCE AUTHORIZING THE SUPPLEMENTAL BUDGET NO. 2, SERIES OF 2025 INVOLVING AN AMOUNT OF TWO MILLION SEVEN HUNDRED THOUSAND PESOS (P2,700,000.00)";

RESOLVED FURTHER, it is understood that this review action does not authorizes any item of appropriation that is specifically prohibited by or inconsistent with the provisions of the law;

RESOLVED FURTHERMORE, the accuracy of the statements/certifications and other supporting documents contained in this supplemental budget as well as observance with other existing laws, rules and other regulations shall be the responsibility of the city government;

RESOLVED FINALLY, compliance with the existing laws, rules and regulations shall be the responsibility of the city government.

This resolution shall take effect immediately upon approval.
