### RESOLUTION NO. 0438 Series of 2025

RESOLUTION DECLARING CITY ORDINANCE NO. 2025-001 OF THE CITY OF HIMAMAYLAN, NEGROS OCCIDENTAL AMENDING SECTION 1 OF CITY ORDINANCE NO. 2024-005, ENTITLED: "NAMING THE UNNAMED STREETS AND ROADS OF VARIOUS BARANGAYS IN THE CITY OF HIMAMAYLAN AS A <u>VALID ENACTED ORDINANCE</u>.

WHEREAS, Section 56 of the Local Government Code of 1991 expresses the reviewing power of the Sangguniang Panlalawigan on Component City and Municipal Ordinances and Resolutions declaring the Ordinance or Resolution valid if it is consistent with the law or invalid in whole or in part if the Sangguniang Panlalawigan finds the Ordinance or Resolution to be beyond the power conferred upon the Sangguniang Panlangsod or Sangguniang Bayan concerned;

WHEREAS, City Ordinance No. 2025-001 of the City of Himamaylan entitled: "An Ordinance amending Section 1 of City Ordinance No. 2024-005, entitled "Naming the unnamed streets and roads of various barangays in the City of Himamaylan" was submitted for review by the City of Himamaylan to the Sangguniang Panlalawigan of Negros Occidental;

WHEREAS, after prompt examination by the Provincial Legal Office, it is the recommendation of the said Office that the subject Ordinance is within the conferred power of the Sangguniang Panlungsod of Himamaylan to enact, thus, the same may be given due course by the Sangguniang Panlalawigan;

WHEREAS, the subject ordinance finds legal basis under the Local Government Code OF 1991 (R.A.7160), specifically Section 13, which grants Local Government Units (LGUs) the authority to name local roads, streets, and public places within their territorial jurisdiction. Section 13 (c) (2), to wit:

- (c) The <u>SANGGUNIANS OF COMPONENT CITIES AND MUNICIPALITIES</u>
  <u>MAY</u>, in consultation with the Philippine Historical Commission, <u>CHANGE THE</u>
  <u>NAME OF THE FOLLOWING WITHIN ITS TERRITORIAL JURISDICTION:</u>
- (1) Xxx
- (2) <u>CITY</u>, MUNICIPAL AND BARANGAY <u>ROADS</u>, avenues, boulevards, thoroughfares, and bridges;

WHEREAS, the Sangguniang Panlungsod of the City of Himamaylan has submitted proof of compliance with the public hearing requirement under Section 59 and the posting and publication requirement under Section 511 of the same Code. These procedural requirements ensure that affected stakeholders have been given an opportunity to be heard and that the ordinance has been properly disseminated to the public;

WHEREAS, the ordinance complies with the six (6) generally accepted principles for a valid ordinance, as adopted by the Sangguniang Panlalawigan of Negros Occidental, which are:

- 1. It must not contravene the Constitution or any statute.
- 2. It must not be unfair or oppressive.
- 3. It must not be partial or discriminatory.
- 4. It must not prohibit but may regulate trade.
- 5. It must be general and consistent with public policy.
- 6. It must not be unreasonable.

WHEREAS, the reviewing authority of the Sangguniang Panlalawigan finds no irregularity that follow thereto as a result of the thorough scrutiny of the Provincial Legal Officer;

**NOW THEREFORE**, premises considered, on motion of Hon. Sixto Teofilo Roxas V. Guanzon, Jr. and unanimously seconded by all the members present,

THE SANGGUNIANG PANLALAWIGAN, RESOLVED, as it hereby resolves, to pass and approve this resolution to wit:
