**RESOLUTION GRANTING AUTHORITY TO THE PROVINCIAL GOVERNOR,  
TO SIGN FOR AND ON BEHALF OF THE PROVINCE, THE DEEDS OF  
DONATION TO BE EXECUTED BY THE PROVINCE OF NEGROS OCCIDENTAL  
IN FAVOR OF THE CITY OF KABANKALAN RELATIVE TO THE DONATION  
OF ONE (1) UNIT ELECTRIC PRICE COMPUTING SCALE FOR MAGHIRUPAY  
CLA WOMEN'S ASSOCIATION IN THE TOTAL AMOUNT OF FOUR  
THOUSAND ONE HUNDRED NINETY PESOS (P4,190.00) AND VARIOUS  
EQUIPMENT FOR KALIBUTAN SOCIETY, INC. IN THE TOTAL AMOUNT OF  
TWENTY FIVE THOUSAND ONE HUNDRED FIFTY FIVE PESOS  
(P25,155.00)**

**WHEREAS**, the request from Gov. Eugenio Jose “Bong” Lacson, dated March 11, 2025, has been forwarded to the Sangguniang Panlalawigan concerning the Deed of Donation between the between the Province of Negros Occidental and municipalities of Hinoba-an and Cauayan;

**WHEREAS**, the Province of Negros Occidental intends to donate one (1) unit Electric Price Computing Scale worth P4, 190.00 to the Maghirupay CLA Women's Association, and various equipment worth P25, 155.00 to the Kalibutan Society, Inc., through the City of Kabankalan, as part of its continuing support to community-based organizations;

*Section 16. General Welfare. - Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants.*

**WHEREAS**, in view of the foregoing, the SP Committee on Laws recommends approval of the same;

**NOW THEREFORE**, on motion of Hon. Sixto Teofilo Roxas V. Guanzon, Jr., unanimously seconded by all the members present;

**THE SANGGUNIANG PANLALAWIGAN RESOLVED**, as it hereby resolves, to grant authority to the Provincial Governor, to sign for and on behalf of the province, the Deeds of Donation to be executed by the Province of Negros Occidental in favor of the City of Kabankalan relative to the donation of one (1) unit Electric Price Computing Scale for Maghirupay Cla Women's Association in the total amount of Four Thousand One Hundred Ninety Pesos (P4,190.00) and various equipment for Kalibutan Society, Inc. in the total amount of Twenty Five Thousand One Hundred Fifty Five Pesos (P25,155.00).
