RESOLUTION DECLARING MUNICIPAL ORDINANCE NO. 2025-203 OF THE MUNICIPALITY OF MOISES PADILLA DECLARING THE TEMPORARY CLOSURE FROM VEHICULAR TRAFFIC, PORTIONS OF ROXAS, BURGOS, GOMEZ AND BONIFACIO ST. ON MARCH 22, 2025 FROM 7AM TO 9AM FOR THE GRAND PARADE, PORTIONS OF BONIFACIO, RIZAL QUEZON ROXAS BURGOS AND GOMEZ ST. ON MARCH 25, 2025 FROM 12NN TO 4PM FOR THE STREET DANCE COMPETITION, PORTIONS OF GOMEZ AND BONIFACIO ST. ON MARCH 25-26 FROM 1PM TO 6PM FOR THE CARNIVAL AND UKAY-UKAY DISPLAY, ALL CONNECTION WITH THE CELEBRATION OF THE 2025 MAGAYON HINUPTANAN FESTIVAL ON THE MUNICIPALITY OF MOISES PADILLA, NEGROS OCCIDENTAL, AS A VALID ENACTED ORDINANCE

WHEREAS, Section 56 of the Local Government Code of 1991 expresses the reviewing power of the Sangguniang Panlalawigan on Component City and Municipal Ordinances and Resolutions declaring the Ordinance or Resolution valid if it's consistent with the law or invalid in whole or in part if the Sangguniang Panlalawigan finds the Ordinance or Resolution to be beyond the power conferred upon the Sangguniang Panlangsod or Sangguniang Bayan concerned;

WHEREAS, Municipal Ordinance No. 2025-203 of the Municipality of Moises Padilla declaring the temporary closure from vehicular traffic, portions of Roxas, Burgos, Gomez and Bonifacio St. on March 22, 2025 from 7am to 9am for the Grand Parade, portions of Bonifacio, Rizal, Quezon, Roxas, Burgos and Gomez St. on March 25, 2025 from 12nn to 4pm for the Street Dance Competition, portions of Gomez and Bonifacio St. on March 25-26 from 1pm to 6pm for the carnival and ukay-ukay display, all connection with the celebration of the 2025 Magayon Hinuptanan Festival of the Municipality of Moises Padilla, Negros Occidental, was submitted for review by the Municipality of Moises Padilla to the Sangguniang Panlalawigan of Negros Occidental;

WHEREAS, after prompt examination by the Provincial Legal Office, it is the recommendation of the said Office that the subject Ordinance is within the conferred power of the Sangguniang Bayan of Moises Padilla to enact, thus, the same may be given due course by the Sangguniang Panlalawigan;

WHEREAS, the enactment of the instant ordinance finds legal support from the Local Government Code of 1991 (R.A. 7160), particularly Section 21, which empowers Local Government Units (LGUS) to temporarily or permanently close or open any local road, alley, park, or square within their jurisdiction, to wit:

Section 21(a) "A local government unit may, pursuant to an ordinance, permanently or temporarily close or open any local road, alley, park, or square falling within its jurisdiction: Provided, however, That in case of permanent closure, such ordinance must be approved by at least two-thirds (2/3) of all the members of the sanggunian, and when necessary, an adequate substitute for the public facility that is subject to closure is provided."

Further, Section 21(d) of the same Code stipulates:

Section 21(d) - "Any city, municipality, or barangay may, by a duly enacted ordinance, temporarily close and regulate the use of any local street, road, thoroughfare, or any other public place where shopping malls, Sunday, flea or night markets, or shopping areas may be established and where goods, merchandise, foodstuffs, commodities, or articles of commerce may be sold and dispensed to the general public."

WHEREAS, in line with these provisions, the Ordinance declaring the temporary closure of portions of Roxas, Burgos, Gomez, and Bonifacio Streets for the Grand Parade on March 22, 2025, as well as portions of Bonifacio, Rizal, Quezon, Roxas, Burgos, and Gomez Streets for the Street Dance Competition on March 25, 2025, is within their power as LGU under the Local Government Code. It also appropriately covers the temporary closure of Gomez and Bonifacio Streets for the Street Party on March 25-26, 2025, and the use of a portion of Rizal Street from March 10-26, 2025, for the Carnival and Ukay-Ukay Display, all in connection with the 2025 Magayon Hinuptanan Festival.

WHEREAS, the ordinance complies with the six (6) generally accepted principles for a valid ordinance, as adopted by the Sangguniang Panlalawigan of Negros Occidental, which are:

It must not contravene the Constitution or any statute.

It must not be unfair or oppressive.

It must not be partial or discriminatory.

It must not prohibit but may regulate trade.

It must be general and consistent with public policy.

It must not be unreasonable.

WHEREAS, the reviewing authority of the Sangguniang Panlalawigan finds no irregularity that follow thereto as a result of the thorough scrutiny of the Provincial Legal Officer;

NOW THEREFORE, premises considered, on motion of Hon. Sixto Teofilo Roxas V. Guanzon, Jr., unanimously seconded by all the members present during the regular session of the Sangguniang Panlalawigan of Negros Occidental, resolved, as it hereby resolves, to pass and approve this resolution to wit:
