DANISE JANSEN TIANGSON OF THE PROVINCIAL GENERAL SERVICES OFFICE (GSO) TO FILE, SUBMIT, PROCESS AND CLAIM THE CERTIFICATES OF TAX CLEARANCE COVERING YEARS 2018 TO 2024, ON BEHALF OF THE PROVINCIAL GOVERNMENT OF NEGROS OCCIDENTAL

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that Local Government Units (LGUs) shall exercise powers necessary, appropriate or incidental for their efficient and effective government and those which are essential to the promotion of the general welfare;

WHEREAS, the Provincial Government of Negros Occidental recognizes the necessity of securing a Tax Clearance Certificate for legal, financial, and administrative compliance with government requirements, which will be done through appointing and granting authority to the above-mentioned representatives;
