RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE MEMORANDUM OF AGREEMENT (MOA) TO BE ENTERED INTO BY AND BETWEEN THE DEPARTMENT OF HEALTH WESTERN VISAYAS CENTER FOR HEALTH DEVELOPMENT AND THE PROVINCE OF NEGROS OCCIDENTAL RELATIVE TO THE IMPLEMENTATION OF THE PERFORMANCE-BASED GRANT PROGRAM TO INCENTIVIZE PROVINCES, CITIES AND MUNICIPALITIES IN WESTERN VISAYAS TO ENHANCE TB-RELATED HEALTH SERVICE
