RESOLUTION AUTHORIZING THE GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE CONTRACT OF LEASE TO BE ENTERED INTO BY AND BETWEEN MA. ELENA C. ANSAG AND THE PROVINCE OF NEGROS OCCIDENTAL RELATIVE TO THE LEASE OF THE APARTMENT UNIT OF MS. ANSAG LOCATED IN BRGY. 3, HDA. MILLAN, ISABELA, NEGROS OCCIDENTAL FOR THE USE AND OCCUPANCY OF PROVINCIAL GOVERNMENT EMPLOYEES ASSIGNED AT THE IGNACIO L. ARROYO, SR. MEMORIAL DISTRICT HOSPITAL WITH A MONTHLY RENTAL FEE OF FIVE THOUSAND PESOS (P5,000.00) FOR THE PERIOD OF JANUARY 1, 2025 TO DECEMBER 31, 2025

WHEREAS, thereby presented to the Board for review and appropriate action is the request of the Governor for authority to sign the Contract of Lease to be entered into by and between Ma. Elena C.
