RESOLUTION APPROVING AND CONCURRING WITH RESOLUTION NO. 1, SERIES OF 2025, OF THE PROVINCIAL HEALTH BOARD OF THE PROVINCE OF NEGROS OCCIDENTAL, ENDORSING TO THE SANGGUNIANG PANLALAWIGAN THE CHANGE OF NAME OF ELEUTERIO T. DECENA MEMORIAL HOSPITAL TO HINOBA-AN DISTRICT HOSPITAL DUE TO THE RELOCATION AND DEVELOPMENT OF A NEW FACILITY AND APPROVING THE NECESSARY STEPS FOR THE RE-NAMING UNDER APPLICABLE LAWS

WHEREAS, Section 106 of RA 7160, otherwise known as the Local Government Code of 1991 provides that "each LGU shall have a comprehensive multi-sectoral development plan to be initiated by its development councils and approved by its sanggunian";

WHEREAS, Section 114 of the said code further provides that the plans, programs and projects proposed by the local development council shall be submitted to the sanggunian concerned for appropriate action;

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Resolution No. 1, series of 2025 of the Provincial Health Board of the Province of Negros Occidental, endorsing to the Sangguniang Panlalawigan the change of name of Eleuterio T. Decena Memorial Hospital to Hinoba-an District Hospital due to the relocation and development of a new facility and approving the necessary steps for the re-naming under applicable laws;
