RESOLUTION AUTHORIZING THE GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE THE MEMORANDUM OF UNDERSTANDING TO BE ENTERED INTO BY AND AMONG THE DEPARTMENT OF AGRICULTURE-REGIONAL FIELD OFFICE, AGRICULTURAL TRAINING INSTITUTE – REGIONAL TRAINING CENTER AND THE PROVINCE OF NEGROS OCCIDENTAL RELATIVE TO THE MODERNIZATION OF AGRICULTURE AND FISHERIES SECTOR TO IMPROVE THE LIVING CONDITIONS OF FARMERS AND FISHERFOLKS OF THE PROVINCE

WHEREAS, thereby presented for appropriate action of the Board is the request for authority to the Provincial Governor to sign, for and in behalf of the province the Memorandum of Understanding to be entered into by and among the Department of Agriculture-Regional Field Office, Agricultural Training Institute – Regional Training Center and the Province of Negros Occidental relative to the modernization of agriculture and fisheries sector to improve the living conditions of farmers and fisherfolks of the province;

WHEREAS, the subject Memorandum of Understanding finds legal basis in Section 465 (b)(1)(vi) of the Local Government Code of 1991, which provides:

- (b) For efficient, effective and economical governance the purpose of which is the general welfare of the province and its inhabitants pursuant to Section 16 of this Codde, the procincial governor shall:
  - Exercise general supervision and control over all programs, projects, services, and activities of the provincial government, and in this connection shall:

(vii) Represent the province in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the sangguniang panlalawigan or pursuant to law or ordinance;

WHEREAS, the subject MOU shall take effect upon signing of the parties and shall continue to be enforced for a period of three (3) years unless otherwise mutually revoked by the parties;

**WHEREAS**, in view of the foregoing, the SP Committee of Agriculture, finding the same to be in order, deemed it best to approve the same;

**NOW THEREFORE**, on motion of Hon. Andrew Gerard L. Montelibano, duly seconded by all the members present,

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to authorize the Provincial Governor to sign, for and in behalf of the province the Memorandum of Understanding to be entered into by and among the Department of Agriculture-Regional Field Office, Agricultural Training Institute – Regional Training Center and the Province of Negros Occidental relative to the modernization of agriculture and fisheries sector to improve the living conditions of farmers and fisherfolks of the province.
