RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE MEMORANDUM OF AGREEMENT (MOA) TO BE ENTERED INTO BY AND BETWEEN CITICORE SOLAR NEGROS OCCIDENTAL, INC. AND THE PROVINCE OF NEGROS OCCIDENTAL RELATIVE TO THE ESTABLISHMENT OF TRUST ACCOUNTS ON THE ACCRUED FINANCIAL BENEFITS FROM THE ELECTRICITY SALES OF THE 25MWdc SOLAR POWER PROJECT OF CITICORE SOLAR NEGROS OCCIDENTAL, INC. IN ACCORDANCE WITH DC2018-08-0021 AND THEREBY AUTHORIZING THE PROVINCIAL TREASURER TO OPEN TWO (2) TRUST ACCOUNTS WITH AN AUTHORIZED GOVERNMENT DEPOSITORY BANK (AGDB) UNDER THE FOLLOWING ACCOUNT NAMES: 1) PROVINCIAL GOVERNMENT OF NEGROS OCCIDENTAL - CSNOI-DLF (ER 1-94) AND 2) PROVINCIAL GOVERNMENT OF NEGROS OCCIDENTAL-CSNOI-RWMHEFF (ER 1-94)

WHEREAS, thereby presented for appropriate action of the Sangguniang Panlalawigan of the Province of Negros Occidental is the Memorandum of Agreement (MOA) to be entered into by and between Citicore Solar Negros Occidental, Inc. and the Province of Negros Occidental relative to the establishment of trust accounts on the accrued financial benefits from the electricity sales of the 25MWdc Solar Power Project of Citicore Solar Negros Occidental, Inc. in accordance with DC2018-08-0021 and thereby authorizing the Provincial Treasurer to open two (2) trust accounts with an Authorized Government Depository Bank (AGDB) under the following account names:
