**RESOLUTION APPROVING RESOLUTION NO. 2025-1709 OF THE CITY OF VICTORIAS APPROVING THE RE-APPROPRIATION OF UNEXPENDED BALANCE OF PROGRAMS/PROJECT/ACTIVITY (PPA) UNDER THE 20% DEVELOPMENT FUND (SUPPLEMENTAL BUDGET NO. 1-2024) IN THE AMOUNT OF P3,318,977.22**

**WHEREAS**, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Resolution No. 2025-1709 of the City of Victorias approving the re-appropriation of unexpended balance of programs/project/activity (PPA) under the 20% Development Fund (Supplemental Budget No. 1-2024) in the amount of P3,318,977.22;

**WHEREAS**, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;
