## RESOLUTION NO. 0508 Series of 2025

RESOLUTION DECLARING ORDINANCE NO. 2024-749 OF THE CITY OF TALISAY ADOPTING REPUBLIC ACT NO. 8172 OTHERWISE KNOWN AS "AN ACT PROMOTING SALT IODIZATION NATIONWIDE AND FOR RELATED PURPOSES" IN THE CITY OF TALISAY, NEGROS OCCIDENTAL AS A <u>VALID ENACTED ORDINANCE</u>

WHEREAS, Section 56 of the Local Government Code of 1991 expresses the reviewing power of the Sangguniang Panlalawigan on Component City and Municipal Ordinances and Resolutions declaring the Ordinance or Resolution valid if it is consistent with the law or invalid in whole or in part if the Sangguniang Panlalawigan finds the Ordinance or Resolution to be beyond the power conferred upon the Sangguniang Panlungsod or Sangguniang Bayan concerned;

WHEREAS, Ordinance No. 2024-749 of the City of Talisay entitled: "An Ordinance adopting Republic Act No. 8172 otherwise known as "An act promoting salt iodization nationwide and for related purposes" in the City of Talisay, Negros Occidental" was submitted for review by the City of Talisay to the Sangguniang Panlalawigan of Negros Occidental;

WHEREAS, after prompt examination by the Provincial Legal Office, it is the recommendation of the said Office that the subject ordinance is within the conferred power of the Sangguniang Panlungsod of Talisay to enact, thus, the same may be given due course by the Sangguniang Panlalawigan;

WHEREAS, the subject ordinance finds sound legal and policy support under the Local Government Code of 1991 (R.A. 7160), particularly under Section 16 (General Welfare Clause) and Republic Act No. 8172, otherwise known as Act for Salt Iodization Nationwide (ASIN);

WHEREAS, Section 16 of R.A. 7160 provides that every local government units (LGU) shall exercise powers essential to promote the general welfare, health, and safety of its people. In this regard, the ordinance aligns with the national policy under Republic Act No. 8172 to eliminate iodine deficiency disorders within the City of Talisay. It also mandates local mechanisms for enforcement, monitoring, education, and coordination among public and private stakeholders;

**WHEREAS**, the ordinance complies with the six (6) generally accepted principles for a valid ordinance, as adopted by the Sangguniang Panlalawigan of Negros Occidental, which are:

- 1. It must not contravene the Constitution or any statute.
- 2. It must not be unfair or oppressive.
- 3. It must not be partial or discriminatory.
- 4. It must not prohibit but may regulate trade.
- 5. It must be general and consistent with public policy.
- 6. It must not be unreasonable.

WHEREAS, the reviewing authority of the Sangguniang Panlalawigan finds no irregularity that follow thereto as a result of the thorough scrutiny of the Provincial Legal Officer;

**NOW THEREFORE**, on motion of Hon. Sixto Teofilo Roxas V. Guanzon, Jr., unanimously seconded by all members present,

THE SANGGUNIANG PANLALAWIGAN RESOLVED as it hereby resolves, to pass and approve this resolution, to wit:
