(BOTICA SIPALAY) RELATIVE TO THE REFERRAL FOR PRESCRIBED DRUGS AND MEDICINE OF INDIGENT PATIENTS OF THE MERCEDITAS J. MONTILLA DISTRICT HOSPITAL UNDER THE PHILHEALTH NO BALANCE BILLING POLICY EFFECTIVE UPON SIGNING THEREOF UNTIL DECEMBER 31, 2025

WHEREAS, thereby presented for appropriate action of the Sangguniang Panlalawigan of the Province of Negros Occidental is the Memorandum of Agreement to be entered into by and between the Province of Negros Occidental and MAREX Pharma Trading Corp. (Botica Sipalay) relative to the referral for prescribed drugs and medicine of indigent patients of the Merceditas J.
