***RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2025-01 OF THE MUNICIPALITY OF CAUAYAN, NEGROS OCCIDENTAL, COVERING THE FY 2025 SUPPLEMENTAL BUDGET NO. 01 OF THE SAID MUNICIPALITY IN THE AMOUNT OF SIXTY EIGHT MILLION FOUR HUNDRED EIGHTY THOUSAND PESOS (P68,480,000.00)***

***WHEREAS***, thereby presented to the Board for review and appropriate action is the FY 2025 Supplemental Budget No. 01 of the Municipality of Cauayan, Negros Occidental with a total appropriation of Sixty Eight Million Four Hundred Eighty Thousand Pesos (P68,480,000.00), enacted by the Sangguniang Bayan per Appropriation Ordinance No. 2025-01;

***WHEREAS***, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A. 7160, otherwise known as the Local Government Code (LGC) of 1991, and its Implementing Rules and Regulations, Budget Operations Manual for Local Government Units, 2023 Edition and implementing circulars and other issuances, as pre-reviewed and endorsed by the Provincial Budget Office and the Local Finance Committee;

***WHEREAS***, in view of the foregoing, the SP Committee on Budget and Finance recommends approval of the same;

**THE SANGGUNIANG PANLALAWIGAN RESOLVED**, as it hereby resolves, to approve and declare operative in its entirety effective March 14, 2025, the Appropriation Ordinance No. 2025-01 of the Municipality of Cauayan, Negros Occidental, subject to the posting requirement under Section 59 of the LGC of 1991, and further subject to the following conditions and reminders:

1. The grant of Terminal Leave Benefits shall be in accordance with CSC Omnibus Rules on Leave pursuant to CSC Memorandum Circular No. 41, s. 1998, BC No. 2013-1 dated April 12, 2013 and BC 2016-2 dated March 29, 2016;
2. The grant of Medical Allowance shall be in accordance with the provisions of Budget Circular No. 2024-6 dated December 12, 2024 of the Department of Budget and Management (DBM);
3. The purchase and specification of the motor vehicles shall be subject to the provisions of Administrative Order No. 14 dated December 10, 2018; Budget Circular (BC) No. 2022-1 dated February 11, 2022 and BC No. 2022-1A dated March 1, 2023 of the DBM;
4. The appropriation for Donations shall be spent solely for public purpose pursuant to Sections 305(b), 335 and 351 of the LGC of 1991;
5. That Section 56 in relation with Section 326 and 327 of the LGC of 1991 provides that within three (3) days after approval of the Ordinance authorizing supplemental appropriations, the Secretary to the Sanggunian shall forward the said Ordinance to the appropriate reviewing authority.

**RESOLVED FURTHER**, that the approval of the subject appropriation ordinance does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law, and that the accuracy of the statements/certifications and other supporting documents contained in this supplemental budget as well as compliance with all existing laws, rules and regulations shall be the responsibility of the municipal government.

This resolution shall take effect immediately upon approval.
