RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE PRESCRIBED FORMS AND FILE FOR THE APPLICATION FOR REQUEST FOR EXEMPTION FOR ALL SOCIAL SERVICES AND HOUSING-RELATED PROJECTS IN CONNECTION WITH THE MAY 12, 2025, NATIONAL AND LOCAL ELECTIONS AND BARMM PARLIAMENTARY ELECTIONS PURSUANT TO COMELEC RESOLUTION NO. 11060

WHEREAS, this Resolution was certified urgent by the Provincial Governor Eugenio Jose "Bong" Lacson relative to the Resolution of the Commission on Elections (COMELEC) under the 1987 Philippine Constitution, is responsible for enforcing election-related laws, including Section 261 (v) of the Omnibus Election Code (OEC), which prohibits the release of public funds for social services and housing projects within forty-five (45) days before a regular election, except under specific exemptions. COMELEC Resolution No. 11060 allows exemptions for such projects, provided a request is filed by February 11, 2025;

WHEREAS, the Provincial Government of Negros Occidental currently has one (1) housing related project and Eighty-Four (84) social welfare and services projects that require exemption to ensure uninterrupted service delivery;

WHEREAS, this Resolution aligns with COMELEC Resolution No. 11060 and is crucial for ensuring the continuous delivery of services to the people of Negros Occidental;

NOW THEREFORE, on motion of Hon. Sixto Teofilo Roxas V. Guanzon, Jr., unanimously seconded by all the members present,
