RESOLUTION APPROVING MUNICIPAL ORDINANCE NO. 002, SERIES OF 2025 OF THE MUNICIPALITY OF PONTEVEDRA, NEGROS OCCIDENTAL TRANSFERRING THE CONTINUING APPROPRIATION UNDER THE LOCAL ECONOMIC ENTERPRISE AND DEVELOPMENT FUND TO THE GENERAL FUND OF THE MUNICIPALITY OF PONTEVEDRA IN THE AMOUNT OF TWO MILLION NINE HUNDRED NINETY SEVEN THOUSAND FOUR HUNDRED SIXTY EIGHT PESOS AND THIRTY NINE CENTAVOS (P2,997,468.39)

WHEREAS, Municipal Ordinance No. 002, Series of 2025 of the Municipality of Pontevedra, Negros Occidental entitled: "An Ordinance transferring the continuing appropriation under the Local Economic Enterprise and Development Fund to the General Fund of the Municipality of Pontevedra in the amount of Two Million Nine Hundred Ninety Seven Thousand Four Hundred Sixty Eight Pesos and Thirty Nine Centavos (P2,997,468.39)" was submitted by the Municipality of Pontevedra for review and appropriate action of the Sangguniang Panlalawigan of Negros Occidental;
