RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE LAND BANK OF THE PHILIPPINES AND THE PROVINCE OF NEGROS OCCIDENTAL RELATIVE TO THE AVAILMENT OF THE PROVINCIAL GOVERNMENT OF LAND BANK'S ATM PAYROLL FACILITY FOR THE CREDITING OF SALARY, ALLOWANCES, BONUSES, AND OTHER COLLATERAL ALLOWANCES, INCLUDING BENEFITS FROM THE PROVINCE OF NEGROS OCCIDENTAL TO THE PROVINCE OF NEGROS OCCIDENTAL PERSONNEL REGARDLESS OF APPOINTMENT STATUS

WHEREAS, thereby presented to the Board for review and appropriate action is the request of the Provincial Governor for authority to sign, for and in behalf of the Province, the Memorandum of Agreement to be entered into by and between the Land Bank of the Philippines and the Province of Negros Occidental relative to the availment of the provincial government of Land Bank's ATM Payroll Facility for the crediting of salary, allowances, bonuses, and other collateral allowances, including benefits from the Province of Negros Occidental to the Province of Negros Occidental personnel regardless of appointment status;

WHEREAS, the subject MOA presents several benefits to the province as this will not only enhance financial management but also, and more importantly, improve transparency and accountability, increase convenience for the employees of the Provincial Government of Negros Occidental, and strengthen internal controls by reducing risk of fraud;

WHEREAS, the Committee on Finance finding the said request and with all the pertinent documents to be in order, deemed it best to approve the same;


NOW THEREFORE, on motion of Hon. Rommel T. Debulgado, unanimously seconded by all the members present,

This resolution shall take effect immediately upon approval.


