## RESOLUTION NO. 0555 Series of 2025

RESOLUTION AUTHORIZING THE GOVERNOR OR THE CHIEF OF HOSPITAL OF THE TERESITA L. JALANDONI PROVINCIAL HOSPITAL TO SIGN, FOR AND IN BEHALF OF THE PROVINCE THE TRIPARTITE AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL THRU THE TERESITA L. JALANDONI PROVINCIAL HOSPITAL, THE URBAN HAZMAT TRANSPORT SERVICES AND THE INTEGRATED WASTE MANAGEMENT, INC. RELATIVE TO THE ESTABLISHMENT OF A COORDINATED SYSTEM FOR THE PROPER HANDLING, TRANSPORT AND TREATMENT OF HAZARDOUS WASTES FROM THE SAID HOSPITAL IN COMPLIANCE WITH RA 6969

WHEREAS, thereby presented for appropriate action of the Board is the request for authority to the Provincial Governor or the Chief of Hospital of the Teresita L. Jalandoni Provincial Hospital to sign, for and in behalf of the province the Tripartite Agreement to be entered into by and between the Province of Negros Occidental thru the Teresita L. Jalandoni Provincial Hospital, the Urban Hazmat Transport Services and the Integrated Waste Management, Inc. relative to the establishment of a coordinated system for the proper handling, transport and treatment of hazardous wastes from the said hospital in compliance with RA 6969;

WHEREAS, the attached agreement defines the responsibilities of each party – generation and packaging by the Teresita L. Jalandoni Provincial Hospital, transport by urban Hazmat Transport Services using accredited vehicles, and the treatment by Integrated Waste Management using approved methods.

WHEREAS, the agreement complies with applicable environmental, health and local governance regulations. It is consistent with Republic Act No. 6969, which mandated the proper handling and treatment of hazardous waste, and align with the Philippine Clean Water Act of 2004 and the
