RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR OR THE CHIEF OF HOSPITAL OF THE TERESITA L. JALANDONI PROVINCIAL HOSPITAL TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL THRU THE TERESITA L. JALANDONI PROVINCIAL HOSPITAL AND THE URBAN HAZMAT TRANSPORT SERVICES RELATIVE TO THE ENGAGEMENT OF URBAN HAZMAT TRANSPORT SERVICES AS THE AUTHORIZED TRANSPORTER OF HAZARDOUS WASTE MATERIALS GENERATED BY TLJPH

WHEREAS, thereby presented for appropriate action of the Sangguniang Panlalawigan of the Province of Negros Occidental is the Memorandum of Agreement to be entered into by and between the Province of Negros Occidental thru the Teresita L. Jalandoni Provincial Hospital and the Urban Hazmat Transport Services relative to the engagement of Urban Hazmat Transport Services as the authorized transporter of hazardous waste materials generated by TLJPH;

WHEREAS, the said MOA is valid for the period of three (3) years from the date of signing thereof, subject for renewal upon mutual consent of both parties;

WHEREAS, the Committee on Health, finding the subject agreement to be favorable and all the necessary documents to be in order, deemed it best to approve the same;
