RESOLUTION AUTHORIZING THE GOVERNOR OR THE CHIEF OF HOSPITAL TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE TRIPARTITE AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL THRU THE CADIZ DISTRICT HOSPITAL, THE URBAN HAZMAT TRANSPORT SERVICES AND THE INTEGRATED WASTE MANAGEMENT, INC. RELATIVE TO THE ESTABLISHMENT OF A COORDINATED SYSTEM FOR THE PROPER HANDLING, TRANSPORT AND TREATMENT OF HAZARDOUS WASTES FROM THE SAID HOSPITAL IN COMPLIANCE WITH REPUBLIC ACT NO. 6969 AND DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES REGULATIONS

WHEREAS, thereby presented to the Board for review and appropriate action is the request of the Governor or the Chief of Hospital for authority to sign, for and in behalf of the Province, the Tripartite Agreement to be entered into by and between the Province of Negros Occidental thru the Cadiz District Hospital, the Urban Hazmat Transport Services and the Integrated Waste Management, Inc. relative to the establishment of a coordinated system for the proper handling, transport and treatment of hazardous wastes from the said hospital in compliance with Republic Act No. 6969 and Department of Environment and Natural Resources regulations;

WHEREAS, the subject Tripartite Agreement complies with applicable environmental, health, and local governance regulations and is consistent with Republic Act No. 6969 (Toxic Substances and Hazardous and Nuclear Wastes Control Act of 1990), the Philippine Clean Water Act of 2004 and the Solid Waste Management Act of 2000;
