RESOLUTION AUTHORIZING THE GOVERNOR OR THE CHIEF OF HOSPITAL OF THE CADIZ DISTRICT HOSPITAL TO SIGN, FOR AND IN BEHALF OF THE PROVINCE THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL THRU THE CADIZ DISTRICT HOSPITAL AND THE URBAN HAZMAT TRANSPORT SERVICES RELATIVE TO THE ENGAGEMENT OF URBAN HAZMAT TRANSPORT SERVICES AS THE AUTHORIZED TRANSPORTER OF HAZARDOUS WASTE MATERIALS GENERATED BY THE SAID HOSPITAL

WHEREAS, thereby presented for appropriate action of the Board is the request for authority to the Provincial Governor or the Chief of Hospital of the Cadiz District Hospital to sign, for and in behalf of the province the Memorandum of Agreement to be entered into by and between the Province of Negros Occidental thru the Cadiz District Hospital and the Urban Hazmat Transport Services relative to the engagement of Urban Hazmat Transport Services as the authorized transporter of hazardous waste materials generated by the said hospital;

WHEREAS, the attach agreement outlines the formal engagement of Urban Hazmat Transport Services as the authorized transporter of hazardous wastes which includes the collection, hauling and delivery of hazardous waste from the Cadiz District Hospital to an accredited treatment facility using EMD-DENR-approved equipment and vehicles;

WHEREAS, the agreement complies with applicable environmental, health and local governance regulations. It is consistent with Republic Act No. 6969, which mandated the proper handling and treatment of hazardous waste, and align with the Philippine Clean Water Act of 2004 and the Solid Waste management Act of 2000, particularly in ensuring accountability throughout the waste management chain;
