RELATIVE TO THE DONATION OF THE SOUTH NEGROS SEA TURTLE CONSERVATION RESEARCH CENTER AT DANJUGAN ISLAND, BULATA, CAUAYAN, NEGROS OCCIDENTAL WITH A TOTAL FLOOR AREA OF 153.72 SQM AND A VALUE OF TWO MILLION PESOS (P2,000,000.00)
