RESOLUTION AUTHORIZING THE GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE SECURITY BANK FOUNDATION, INC., SECURITY BANK CORPORATION, THE DEPARTMENT OF EDUCATION SCHOOLS DIVISION OF NEGROS OCCIDENTAL AND THE PROVINCE OF NEGROS OCCIDENTAL RELATIVE TO THE IMPLEMENTATION OF THE "BUILD A SCHOOL, BUILD A NATION: THE CLASSROOM PROJECT", A PUBLIC-PRIVATE PARTNERSHIP INITIATIVE FOR THE CONSTRUCTION OF SCHOOL BUILDINGS AND IMPROVEMENT OF QUALITY OF BASIC EDUCATION THROUGH TRAININGS AND RELATED INTERVENTIONS IN THE PROVINCE OF NEGROS OCCIDENTAL.
