RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR TO SIGN, FOR AND ON BEHALF OF THE PROVINCE, THE MEMORANDUM OF AGREEMENT (MOA) TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND THE DEPARTMENT OF EDUCATION – DIVISION OF NEGROS OCCIDENTAL RELATIVE TO THE FINANCIAL ASSISTANCE THAT WILL BE EXTENDED BY THE PROVINCE FOR THE CONDUCT OF A LEADERSHIP TRAINING FOR STUDENT LEADERS IN DIFFERENT ADVOCATES IN THE AMOUNT OF TWO HUNDRED FIFTY THOUSAND PESOS (P250,000.00) TO BE TAKEN FROM THE 2025 PCPC FUND
