RESOLUTION APPROVING/CONCURRING WITH RESOLUTION NO. 03, SERIES OF 2025 OF THE PROVINCIAL DISASTER RISK REDUCTION MANAGEMENT COUNCIL (PDRPMC) OF THE PROVINCE OF NEGROS OCCIDENTAL APPROVING THE RE-ALIGNMENT/RE-PROGRAMMING OF THE UNEXPENDED/UNOLIBIGATED AMOUNT UNDER THE 5% PDRRMF-SPECIAL TRUST FUND (STF) AMOUNTING TO ONE HUNDRED SEVENTY TWO MILLION TWO HUNDRED FORTY FOUR THOUSAND FIVE HUNDRED FIFTY FOUR PESOS AND THIRTY NINE CENTAVOS (P172,244,554.39)
