RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND THE BACOLOD GIRLS' HOME FOUNDATION, INC. RELATIVE TO THE FINANCIAL ASSISTANCE THAT WILL BE EXTENDED BY THE PROVINCE FOR THEIR PROJECT, ENTITLED: "SUPPORT TO FORMAL EDUCATION & BASIC NEEDS OF CHILDREN AT BACOLOD GIRLS' HOME FOUNDATION, INC."
