RESOLUTION DISAPPROVING APPROPRIATION ORDINANCE NO. 01, SERIES OF 2025 OF THE CITY OF SILAY, NEGROS OCCIDENTAL ENTITLED: "AN ORDINANCE AMENDING APPROPRIATION ORDINANCE NO. 6, SERIES OF 2024 ENTITLED: "AN ORDINANCE APPROPRIATING THE AMOUNT OF EIGHTY-THREE MILLION FOURTEEN THOUSAND ONE HUNDRED NINETY-FIVE PESOS AND SIXTY CENTAVOS (P83,014,195.60)

WHEREAS, thereby presented for appropriate action of the Sangguniang Panlalawigan of the Province of Negros Occidental is Appropriation Ordinance No. 01, Series of 2025 of the City of Silay, Negros Occidental entitled: "AN ORDINANCE AMENDING APPROPRIATION ORDINANCE NO. 6, SERIES OF 2024 ENTITLED: "AN ORDINANCE APPROPRIATING THE AMOUNT OF EIGHTY-THREE MILLION FOURTEEN THOUSAND ONE HUNDRED NINETY-FIVE PESOS AND SIXTY CENTAVOS (P83,014,195.60);

WHEREAS, the pre-review of AO No. 01, series of 2025 shows that it is the amendment to AO No. 6, series of 2024;

WHEREAS, pursuant to the assessment by the Provincial Budget Officer (PBO), one of the sources of fund was "Excess Collection" as reflected in the AO No. 06, series of 2024;

WHEREAS, said AO No. 06 failed to provide for the mandated 5% Local Disaster Risk Reduction Management Fund (LDRRMF) as a requirement under Section 324 of the Local Government Code of 1991;

WHEREAS, Section 353 of the same code also provides that the official fiscal year of LGUs shall be the period beginning with the first (1st) day of January and ending with the thirty-first (31st) day of December of the same year;

WHEREAS, the reversion of funds under Section 322 of the LGC is also at the end of the fiscal year (except in cases of continuing appropriations when the capital outlay projects are not yet completed);

WHEREAS, the Committee on Finance, recommends disapproval and declare the same inoperative in its entirety effective immediately;

NOW THEREFORE, on motion of Hon., Jeffrey T. Tubola, unanimously seconded by all the members present,
