


JANET T. MOLEÑO OF THE DON SALVADOR BENEDICTO MEMORIAL DISTRICT HOSPITAL IN THE TOTAL AMOUNT OF TWENTY EIGHT THOUSAND NINE HUNDRED NINETY NINE PESOS AND FOUR CENTAVOS (P28,999.04)
