RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND ALLIED HOSPITAL SUPPLY INTERNATIONAL CORPORATION FOR THE FREE LOAN, USE AND MAINTENANCE OF VARIOUS LABORATORY EQUIPMENT RENOVATION OF DESIGNATED HOSPITAL LABORATORY INCLUDING SECTIONS OF IGNACIO L. ARROYO SR. MEMORIAL DISTRICT HOSPITAL, DON SALVADOR BENEDICTO MEMORIAL DISTRICT HOSPITAL, ELEUTERIO T. MEMORIAL HOSPITAL, **MERCEDITAS** MONTILLA DISTRICT DECENA HOSPITAL, AND LORENZO D. ZAYCO DISTRICT HOSPITAL

WHEREAS, thereby presented for appropriate action of the Sangguniang Panlalawigan of the Province of Negros Occidental is the Memorandum of Agreement to be entered into by and between the Province of Negros Occidental and Allied Hospital Supply International Corporation for the free loan, use and maintenance of various laboratory equipment including renovation of designated hospital laboratory sections of Ignacio L. Arroyo Sr. Memorial District Hospital, Don Salvador Benedicto Memorial District Hospital, Eleuterio T. Decena Memorial Hospital, Merceditas Montilla District Hospital, and Lorenzo D. Zayco District Hospital;

**WHEREAS**, the MOA provides that Allied, without cost to the Province, shall lend the following laboratory equipment to be installed at the laboratory section of the said hospitals:

- 1. One (1) unit CBS-400 Electrolyte Analyzer;
- 2. One (1) unit Mindray BC-760 Automated Hematology Analyzer;
- 3. One (1) unit Mindray BC-430 Automated Chemistry Analyzer;
- 4. One (1) unit Immunology Machine;

- 5. One (1) unit Coagulation Machine; and
- One (1) unit Hba 1c Machine.

WHEREAS, the said agreement includes free use and renovation of the laboratory areas of the said hospitals where the instruments will be housed for the upgrading of their laboratories from secondary to tertiary level, with a 7-year renewable term and maintenance services provided by Allied at no additional cost for the province;

**WHEREAS**, the Committee on Health, finding the subject agreement to be favorable and all the necessary documents to be in order, deemed it best to approve the same;

**NOW THEREFORE**, on motion of Hon. Araceli T. Somosa, unanimously seconded by all the members present,

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to authorize the Governor to sign, for and in behalf of the province, the Memorandum of Agreement to be entered into by and between the Province of Negros Occidental and Allied Hospital Supply International Corporation for the free loan, use and maintenance of various laboratory equipment including renovation of designated hospital laboratory sections of Ignacio L.
