RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2025-02 OF THE CITY OF LA CARLOTA, NEGROS OCCIDENTAL, COVERING THE 2025 GENERAL FUND SUPPLEMENTAL BUDGET NO. 2 OF THE SAID CITY IN THE AMOUNT OF EIGHTY SEVEN MILLION SEVEN HUNDRED SEVENTY FIVE THOUSAND SEVEN HUNDRED TEN PESOS AND TWELVE CENTAVOS (P87,775,710.12)

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the 2025 General Fund Supplemental Budget No. 2 of the City of La Carlota, Negros Occidental with a total appropriation of P87,775,710.12, enacted by the Sanggunian Panlangsod per Appropriation Ordinance No. 2025-02;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A. No. 7160, otherwise known as the Local Government Code of 1991, and Joint Circular No. 93-2 of the Commission on Audit and the Department of Budget and Management dated June 8, 1993 and other implementing circulars and issuances, as pre-reviewed and endorsed by the Provincial Budget Officer and the Local Finance Committee;

WHEREAS, in view of the foregoing, the SP Committee on Budget and Finance recommends approval of the same;

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Appropriation Ordinance No. 2025-02 of the City of La Carlota covering the 2025 General Fund Supplemental Budget No. 2 of the said city with a total appropriation of P87,775,710.12 and considered operative in its entirety effective March 3, 2025 subject to the posting requirement under Section 59 of LGC 1991 and the following conditions and reminders:

- the grant of Terminal Leave Benefits shall be in accordance with CSC Omnibus Rules on Leave pursuant to CSC MC No. 41, series of 1998, BC No. 2013-1 dated April 12, 2013 and BC No. 2016-2 dated March 29, 2016;
- 2. the appropriation for wages Casual/Contractual shall be subject to pertinent budgeting, accounting and auditing rules and regulations, and to the following provisions of CSC's 2017 Omnibus Rules on Appointments and Other Human Resource Actions, as follows; (1) Employees under contractual or casual appointment are entitles to the same benefits enjoyed by regular employees; and (2) in no case shall a casual appointment be issued to fill a vacant plantilla position or a casual employee perform the duties and responsibilities of the vacant plantilla position;
- 3. the payment of PERA shall be pursuant to BC Nos. 2009-3 dated August 18, 2009 and 2011-2 dated September 26,2011 of the DBM; and
- 4. the LGU is encouraged to strictly adhere to the period of submission of Appropriation Ordinances to the Sangguniang Panlalawigan for review per Section 56(a) of RA 7160 which states that: "Review of Component Cities and Municipal Ordinances or Resolutions by the Sangguniang Panlalawigan (a) within three (3) days after approval, the Secretary to the Sangguniang Panlungsod or Sangguniang Bayan shall forward to the Sangguniang Panlalalawigan for review, copies of approved ordinances and resolutions approving local development plans and public investment programs formulated by the local development councils".

RESOLVED FURTHER, that the accuracy of the statement/certification and other supporting documents contained in this supplemental budget as well as the observance with other existing laws, rules and regulations shall be the responsibility of the city government.

ADOPTED UNANIMOUSLY.

This resolution shall take effect immediately upon approval.
