RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2025-04 OF THE CITY OF LA CARLOTA, NEGROS OCCIDENTAL, COVERING THE 2025 GENERAL FUND SUPPLEMENTAL BUDGET NO. 4 OF THE SAID CITY IN THE AMOUNT OF ONE HUNDRED SIXTY THOUSAND SEVENTY SEVEN PESOS (P160,077.00)

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the 2025 General Fund Supplemental Budget No. 4 of the City of La Carlota, Negros Occidental with a total appropriation of P160,077.00, enacted by the Sanggunian Panlungsod per Appropriation Ordinance No. 2025-04;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A. No. 7160, otherwise known as the Local Government Code of 1991, and Joint Circular No. 93-2 of the Commission on Audit and the Department of Budget and Management dated June 8, 1993 and other implementing circulars and issuances, as pre-reviewed and endorsed by the Provincial Budget Officer and the Local Finance Committee;

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Appropriation Ordinance No. 2025-04 of the City of La Carlota covering the 2025 General Fund Supplemental Budget No. 4 of the said city with a total appropriation of P160,077.77 and considered operative in its entirety effective April 14, 2025 subject to the posting requirement under Section 59 of LGC 1991 and the reminder to strictly adhere to the period of submission of Appropriation Ordinances to the Sangguniang Panlalawigan for review per Section 56(a) of RA 7160 which states that: "Review of Component Cities and Municipal Ordinances or Resolutions by the Sangguniang Panlalawigan - (a) within three (3) days after approval, the Secretary to the Sangguniang Panlungsod or Sangguniang Bayan shall forward to the Sangguniang Panlalawigan for review, copies of approved ordinances and resolutions approving local development plans and public investment programs formulated by the local development councils".

RESOLVED FURTHER, that the accuracy of the statement/certification and other supporting documents contained in this supplemental budget as well as the observance with other existing laws, rules and regulations shall be the responsibility of the city government.

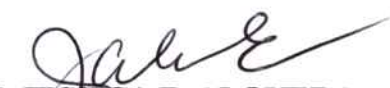
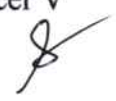
