RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2025-003 OF THE MUNICIPALITY OF MOISES PADILLA, NEGROS OCCIDENTAL, COVERING THE FY 2025 GENERAL FUND SUPPLEMENTAL BUDGET NO. 3 OF THE SAID MUNICIPALITY IN THE AMOUNT OF FOURTEEN MILLION EIGHT HUNDRED SIXTY THOUSAND PESOS (P14,860,000.00)

WHEREAS, thereby presented to the Board for review and appropriate action is the FY 2025 General Fund Supplemental Budget No. 3 of the Municipality of Moises Padilla, Negros Occidental with a total appropriation of Fourteen Million Eight Hundred Sixty Thousand Pesos (P14,860,000.00), enacted by the Sangguniang Bayan per Appropriation Ordinance No. 2025-003;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A. 7160, otherwise known as the Local Government Code of 1991, Budget Operations Manual for Local Government Units, 2023 Edition, implementing circulars and other issuances, as pre-reviewed and endorsed by the Provincial Budget Office and the Local Finance Committee;

RESOLVED FURTHERMORE, that the accuracy of the statements/certifications and other supporting documents contained in this supplemental budget as well as observance with other existing laws, rules and regulations shall be the responsibility of the municipal government.
