RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 01, SERIES OF 2025 OF THE MUNICIPALITY OF E.B. MAGALONA, NEGROS OCCIDENTAL, COVERING THE FY 2025 GENERAL FUND SUPPLEMENTAL BUDGET NO. 1 IN THE AMOUNT OF THREE MILLION THREE HUNDRED EIGHTY FIVE THOUSAND ONE HUNDRED THIRTY FOUR PESOS AND NINETY THREE CENTAVOS (P3,385,134.93)

WHEREAS, thereby presented to the Board for review and appropriate action is the FY 2025 General Fund Supplemental Budget No. 1 of the Municipality of E.B. Magalona, Negros Occidental with a total appropriation of Three Million Three Hundred Eighty Five Thousand One Hundred Thirty Four Pesos And Ninety Three Centavos (P3,385,134.93), enacted by the Sangguniang Bayan of the said municipality per Appropriation Ordinance No. 01, Series of 2025;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A. 7160, otherwise known as the Local Government Code of 1991, Budget Operations Manual, 2023 Edition for Local Government Units and implementing circulars and other issuances, as pre-reviewed and endorsed by the Provincial Budget Office and the Local Finance Committee;

WHEREAS, in view of the foregoing, the SP Committee on Finance recommends approval of the same,

NOW, THEREFORE, on motion of Hon. Rommel T. Debulgado and unanimously seconded by all the members present,

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve and consider operative in its entirety effective April 5, 2025, the Appropriation Ordinance No. 01, Series of 2025 of the Municipality of E.B. Magalona, Negros Occidental, subject to the posting requirements under Section 59 of the Local Government Code of 1991 and the reminder to strictly adhere to the period as to the submission of Appropriation Ordinances to the Sangguniang Panlalawigan for review per Section 56(a) of R.A. 7160, which states that: *"Review of Component City and Municipal Ordinances or Resolutions by the Sangguniang Panlalawigan - (a) Within three (3) days after approval, the secretary to the sanggunian panlungsod or sangguniang bayan shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and the resolutions approving the local development plans and public investment programs formulated by the local development councils."*

RESOLVED FURTHER, that this resolution does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law;

RESOLVED FURTHERMORE, that the accuracy of the statements/certifications and other supporting documents contained in this supplemental budget as well as observance with other existing laws, rules and regulations shall be the responsibility of the municipal government.

ADOPTED UNANIMOUSLY.

This resolution shall take effect immediately upon approval.
